 - **B. Mail-In Entry Without Purchase:** To enter without making a purchase, an eligible entrant may hand-write his/her complete name (no initials), valid e-mail address, street address (P.O. Boxes not accepted), city, state, ZIP code, telephone number, and date of birth (MM/DD/YYYY) on a 3½"x5" card ("Mail-In Entry") and mail it with sufficient postage to: Dollar General Survey Sweepstakes, P.O. Box 251328, West Bloomfield, MI 48325. A Mail-In Entry must be postmarked by the Entry Period End Date and received by the Mail-In Entry Received by Date (as indicated in Section 1) to be eligible for the applicable Entry Period. An entrant will receive one (1) entrant into the applicable Entry Period for a valid Mail-In Entry. Mail-In Entries must be legibly hand-written.
